SPECIFIC DUTIES

The Communication and Media Intern in the IOM Country Office for Austria will mainly perform duties related to the implementation of the project “The European Migration Network (EMN)” of the Research and Migration Law Unit. The main responsibilities are:

1. **Monitoring of the Austrian media:** the intern produces weekly and monthly press reviews as well as media-related research by using an online media monitoring software (approx. 30%);
2. **Editing, proof reading and translation:** the intern supports the team in the production and publication of print and digital products as well as with translation German/English (approx. 30%);
3. **Event management:** the intern assists the team in the planning, organization and implementation of conferences, workshops and other events (approx. 20%);
4. **Online content management:** the intern independently writes, edits and uploads content to the website www.emn.at (approx. 10%).

Other responsibilities include (approx. 10%):

- Performing research tasks on the topic of migration and asylum;
- Attend internal and external meetings, seminars, and workshops upon request;
- Perform any other tasks that may be assigned.

GENERAL INFORMATION

The duration of the internship is 6 months with 40 hrs work per week. The internship is remunerated with an amount of 612 € per month. Interviews are conducted via Skype. Travel costs cannot be reimbursed by the IOM Country Office for Austria. Only shortlisted candidates will be contacted.

BACKGROUND

International Organization for Migration (IOM) – the UN Migration Agency

Established in 1951, the International Organization for Migration (IOM) is the leading intergovernmental organization in the field of migration and is committed to the principle that humane and orderly migration benefits migrants and society. IOM works with its partners in the international community to assist in meeting the growing operational challenges of migration, advance understanding of migration issues, encourage social and economic development through migration and uphold the well-being and human rights of migrants.

IOM Country Office Austria

The main responsibility of the IOM Country Office for Austria is to analyze national migration issues and emerging trends to develop and implement projects and programmes to address these. The Country Office for Austria includes five units: the Assisted Voluntary Return and Reintegration Unit; the Integration Unit; the Research and Migration Law Unit; the Operations Unit and the Resource Management Unit. The incoming intern will be part of the Research and Migration Law Unit and work on migration research.

The European Migration Network (EMN)

The main project of the Research and Migration Law Unit is the work as the National Contact Point Austria in the European Migration Network (EMN). The [EMN](#) was set up in 2003 by the [European Commission](#) on behalf of the European Council in order to satisfy the need for a regular exchange of reliable information on migration and asylum-related issues at European level. In 2003 the IOM Country Office for Austria was nominated as National Contact Point Austria by the Austrian Federal Ministry of the Interior.

The objective of the EMN is to meet the information needs, of Community institutions and of Member States' authorities and institutions on migration and asylum, by providing up-to-date, objective, reliable and comparable information on migration and asylum, with a view to supporting policymaking in the European Union in these areas and to providing a factual basis for current discussions. The EMN responds to information needs through reports, studies, Ad-Hoc Queries, so called "EMN Informs", the EMN Bulletin and the EMN Glossary. The EMN analyses and synthesizes such information to improve its comparability and support harmonization at EU level.
